

Safety

Safety Overview

The following general safety precautions must be observed during all phases of operation, service, and repair of this equipment. Additional Safety Information

As with any mechanical device, care must be taken during the installation, operation, and maintenance of the device in order to realize the maximum benefit from its ownership.

When raising and lowering the load, be aware of pinch points. Keep hands and feet away from these areas.

When transporting a load, it is recommended that the drum is lowered as close to the floor as possible to reduce the chances of accidents during transport.

Do not leave load suspended for and extended period of time or premature wear to the lifting cylinder may occur.

Activate safety brake on the swivel caster when Raptor is not in use.

Note: All personnel involved in the use and maintenance of this device should be thoroughly familiar with the information contained in this manual. Furthermore, it is recommended that all personnel be given adequate instruction and a sufficient period of training in its actual use to insure safety of personnel and proper care of the equipment. It is suggested that the unit be initially operated empty until becoming familiar with how the unit handles.

Product Description

The Raptor with Beak has been engineered for easy access and maneuverability. The simple design makes it an efficient way of handling drums on pallets and containment skids. It allows the operator to safely manipulate virtually any kind of drum up to 800lbs, while reducing injury to the operator.

Features

The Raptor with Beak offers state-of-the-art design with many advanced features.

- Hand operated heavy duty hydraulic pump to raise and lower the drum.
- Hands Free Drum claw type grab attached to the rim of the drum.
- V-leg design makes it an efficient way of handling drums on and around pallets and containment skids.
- The small foot print is ideal for negotiating narrow aisles and doorways.
- Rear swivel phenolic caster with brake and two front fixed phenolic wheels allows the operator to move drums easily.

Receiving and Inspecting

When unpacking the Harrier, inspect the equipment for damage or mishandling. If damage is noted, file a damage claim with the carrier within 24 hours and call Valley Craft at 1-800-328-1480. Do not attempt to use the equipment.

Compare the contents of the shipment with the bill of lading. Report any missing items to the carrier and to Valley Craft immediately.

Operating Procedures

Only authorized personnel are permitted to use the Harrier. Every load and every situation is different. Every lift must be evaluated and planned. Observe the following procedures when using this equipment.

- To handle 55 and 85 gallon drums, the beak should be attached through the upper two holes of the back plate.
- To handle 30 gallon drums, the beak should be attached through the lower two holes of the back plate.
- To RAISE the Drum Claw.
- Position the lever on top of the hydraulic pump in the left horizontal position, move the pump handle up and down.
- To LOWER the drum claw:
- The speed of decent can be regulated by rotating the nob on the front of the hydraulic pump counter clock wise. To stop lowering, rotate the nob clock wise.
- To TRANSPORT the Drum:
 - 1. Raise or lower the claw to a height slightly above the top of the drum.
 - 2. Move the Raptor forward until the drum cradle comes in contact with the drum.
 - 3. Lower the claw over the lip of the drum. When the claw has engaged the lip of the drum raise the drum and transport as needed.
 - 4. To release the drum, lower the drum to the floor and simultaneously back the Raptor away from the drum. There needs to be some pressure against the bottom portion of the hook to allow the top part to open and clear the drum when backing away.

Maintenance and Adjustment Procedures

To keep the Harrier operating properly, timely maintenance and adjustments are required. These procedures should be performed only by qualified personnel who are familiar with the equipment.

As with any mechanical hydraulic actuator (piston rods, rotating pump shaft, etc.) the shaft will become coated with a minute amount of oil from the internal high pressure system. The rod protruding from the cylinder and hand pump may feel damp with oil after use. This is desirable because the oil coating serves to lubricate the shaft seal, reducing friction and assuring extended seal life.

Maintenance and adjustment procedures are shown in Table 1.

Hydraulic Fluid	Every 40 hours or after long set-aside periods	Check Fluid	Make sure cylinder is fully retracted. Fill Reservoir to within 1 in. to 2 in. of the fill hole. Use Super ATF Transmission Fluid.
			*NOTE: To fill/change reservoir, remove pump pod that sits on top of reservoir. See Sheet # 10
	Yearly	Flush hydraulic system	Drain all hydraulic fluid and replace with 48 ounces of Super ATF Transmission Fluid. Make sure cylinder is fully retracted.
	At Start of Shift	Operate	Fully extend lift cylinder to purge oil from rod end of the cylinder

The Harrier is a quality product that is designed and manufactured to provide prolonged service under normal operating conditions. If troubleshooting is required, it should be performed only by qualified personnel who are familiar with the equipment.

Replacement Procedures





Technical Assistance/Warranty Procedure

What's Covered:

- Parts and Labor to correct manufacturer's defect within one year of purchase.
- Freight Cost

What's Not:

Normal wear items (seal kits, bearings, tires, etc.)

What Voids the Warranty:

- Dirt/Grime that directly causes malfunction of product
- Abuse (i.e. Overloading, damaged, not property maintained, etc.)
- Product altered by customer
 - *See "Items not Under Warranty" below for items that have the warranty voided.

Items Under Warranty (less than one year old):

Warranty replacement parts are provided only when the problem can be identified with near certainty. If not, the
customer will return item to Valley Craft, freight collect, for troubleshooting and/or repair. When repaired, product
will be returned to customer, freight prepaid. Otherwise, customer may call local authorized service technician for
assistance. Under this arrangement, replacement parts will be sent at no charge but labor costs will NOT be
covered.

Items NOT Under Warranty (greater than one year old or "having warranty voided):

Customer will return item to valley Craft, freight prepaid, for troubleshooting and/or repair. Valley Craft will call
customer with \$\$ estimate of parts and labor for approval before repairing. Product will be returned to customer,
freight collect.

Or

Customer may call local authorized service technician for repairs at their own expense.
